This includes overview and modern understanding of classical topics including plant competition, herbivory, succession, pollination, and plant-plant interactions. The course will also emphasize the importance of practical applications of plant ecology such as conservation biology, ecological restoration, and wildlife management. In this course we will emphasize Florida plants and ecosystems. Upon completion of this course, students will have gained a comprehensive understanding of plant ecology and its relevance to local and global ecological issues.



Student Learning Outcomes

By the end of the course, students will be able to:

- Explain the processes that influence species distribution and abundance using examples of populations or communities shaped by these processes.
- Discuss interactions between species and the environment that determine community composition and structure.
- Explain how models and other analytical techniques are used to explain population growth and community structure.
- Apply ecological principles to current conservation issues.
- Critically analyze papers from the ecological literature.

All quizzes and exams will feature content from the textbooks. Other selected articles and readings will be posted on Canvas. Students are expected to complete all required readings <u>before</u> the corresponding class session. You may also be required to watch brief videos before class, which will be posted on Canvas as well.

Computer Requirement: All students must have regular access to a computer with a reliable internet connection to access assignments and materials on Canvas.

Communication & Conduct

Meeting Policy: Students are encouraged to come to office hours or schedule a time to meet with the instructor if they are struggling. Outside of office hours, email is the preferred method of contact. I will do my best to respond to messages within 48 hours (not including weekends or holidays). As a courtesy, please check the syllabus and Canvas before reaching out; answers to many of your questions can be found there!

Canvas: Important announcements and updates will be regularly posted to the course Canvas website, so be sure to check Canvas frequently! To ensure that you do not miss anything, please ensure that your Canvas profile is set to receive notifications.

Email Accounts: It is UF policy that you use your GatorLink account or Canvas when emailing your instructors; we will not answer emails sent from other accounts (e.g., personal Gmail, etc).

Projects & Assignments



Quizzes (20%): There will be a total of 10 short online quizzes throughout the semester (see Canvas for dates). Students will need complete each quiz prior to the start of each class. Quizzes will focus primarily on the textbook and lessons from field trip lectures.

Reflections (10%): Throughout the semester, you will be asked to submit 10 brief reflections via Canvas. The instructor will prompt reflections with a question(s). Students will have from Tuesday (afternoon) to Sunday (midnight) to complete the reflections. Students are encouraged to reply to reflections made by others. The goal of these reflections is to help you expand on our discussions and think deeply about topics discussed in the textbook, readings, and field lectures. Some reflections, you may be asked to analyze a relevant scientific paper related to the topic that week.

Exams (35%): There will be two online exams in this course (via Canvas), a mid-term (15%) and final (20%). The mid-term will feature questions on content primarily from the textbook but will also include some information from field lectures. Students are encouraged to take notes during field lectures and while reading the textbook. Both exams are open notes but are time limited.

ChatGPT Writing Assignment (20%): Students will pick a topic of their choice related to Plant Ecology (approved by instructor). Students will then use the online free version of ChatGPT to produce a two-page report on the topic. The report should include the history, development, opposing views, and modern takes on the topic. The report must also include citations and a reference page. Using the report that ChatGPT provides, students will then provide a two-page critique, highlighting incorrect or misinterpreted statements. Students will be expected to critically examine the topic via their own review of the literature. Using tract changes, students will then use the report ChatGPT provided to enhance the report. This version of the report should reach 5 - 8 pages (not including the two-page critique). Extra credit points will be given to students that use reference manager such as Mendeley within their report. Attendance (15%): Students are required to attend and participate in the course and field trips. Attendance will be taken for each class session. Make-up periods will <u>not</u> be provided. All students are expected to attend every class session on time and stay for the entire session.

Extra Credit: Extra credit assignments may be posted at the **instructors' discretion only**. Any other extra work submitted in order to raise a grade will not be accepted and requests for additional extra credit will not be considered.

Missed Classes & Assignments:

* All assignments must be submitted electronically via Canvas unless otherwise noted. Emailed or paper submissions for Canvas assignments will not be accepted. You are responsible for ensuring that all your work is uploaded correctly and completely by the deadline. Corrupted files will be treated as missing work (= 0 grade) until they are reuploaded correctly and late penalties will apply if your resubmission is past the deadline. Always double check your files right after you upload them. If you experience technical problems when submitting your work in Canvas, contact the UF Computing Help Desk for assistance: https://helpdesk.ufl.edu.

*No make-up exams or classes will be given without prior permission or documentation of illness. Students that will be missing an exam due to a pre-arranged university-approved excused absence (sports, religious reasons, medical, etc.) should let the instructor know a minimum of two weeks in advance. These students may be required to take the makeup exam before the scheduled inclass exam. In case of illness on exam day, a letter from the student's primary care provider is required. This letter must state that the student was unable to complete the exam on the scheduled date (i.e., a letter stating only that the student was seen in a clinic is not sufficient)



and must go through the Dean of Students Instructor Notification system (https://care.dso.ufl.edu/instructor-notifications/). A personal matter must also go through the same process. These notes must be received within five business days after the exam. Make up exams may be short-answer or essay format.

This course uses a points system for grading. The anticipated maximum that can be earned in the course is **1000 points**, distributed as follows:

*Disputing a grade: If you wish to dispute a grade for any exam/assignment, you must contact the instructors in writing within two days (48 hours) after the assignment has been returned. In your message, you must include a specific explanation for why you think the grade is incorrect and how you think it should be changed. An instructor will then arrange a meeting with you to discuss the issue and determine whether to the grade should be changed. The grade assigned following this meeting will be final.

Attendance & Participation

Due to the hands-on nature of this course, attendance in class is *critically important*. All students are expected to **attend every class session on time** and **stay for the entire session**. Since this is a **face-to-face course**, you will *not* have the option to join remotely via Zoom (and our class sessions will not be recorded). <u>Students who miss more than 30% of class sessions will automatically earn an E (= failing grade) in the course</u>.

Students are also expected to be **fully prepared for and engaged** in each session– this includes completing all required readings/videos, submitting all assignments on time, paying

attention during class, and actively participating in all class activities. Participation in class sessions is worth **15% of your final course grade**.

If you need to miss a class due to an **excusable absence**, you must let the instructors know **as far in advance as possible** to discuss arrangements for making up missed work. Excusable absences include serious illness or injury, family emergencies, approved professional activities, severe weather, religious holidays, & court-imposed legal obligations. In order to make up missed work, you will be required to submit appropriate documentation of your absence via the official Instructor Notification portal: <u>https://care.dso.ufl.edu/instructor-notifications</u>.

If you are absent for any other reason or fail to notify the instructors of your absence in a timely manner, you will earn a 0 for attendance that class period. Please note that personal travel/vacations are not considered excusable absences, and thus students will earn a 0 for any work missed due to personal travel/vacations during the course.

If you do miss a class meeting, we recommend that you contact a classmate for notes from that session; the instructors will not provide notes. If the content is still unclear after you review your classmate's notes (and the required readings/other materials on Canvas), please don't hesitate to come to office hours or schedule a meeting with the instructor. Please come to that meeting prepared to discuss the specific questions you have.

Late Work & Make-Up Assignments

All assignments are due by the date and time indicated on the assignment page in Canvas. Extensions for assignments will be considered on a *case-by-case basis* (and granted at the instructors' discretion) only in the event of unforeseen emergencies. In such a case, you must contact the instructors as soon as possible to discuss your situation. You must also submit appropriate documentation of your emergency via the official Instructor Notification portal in a timely manner: https://care.dso.ufl.edu/instructor-notifications. No extensions will be granted for students who miss a deadline for any other reason. Please note that credit cannot be earned on any assignment that is submitted after the instructor has graded and returned that assignment to the class, regardless of the circumstances. Late work will also not be accepted after the deadline for the final assignment in the course.

*A note about deadlines: Remember, the due date doesn't have to be the "do" date! In other words, we encourage you to work on your assignments in advance- don't wait until right before the deadline to submit your work! Last-minute computer problems or other non-emergency situations that arise right before the submission cut-off are not valid reasons for requesting an extension. Such requests will not be considered, and the late penalties described above will be applied to your work if it is not submitted on time.

Field Guidelines

This course is centered on outdoor field trips. Be aware that there are some inherent risks with being outdoors, this includes ticks, chiggers, mosquitoes, and poisonous snakes. Students are required to dress appropriately for the field and follow instructions to help minimize unpleasant encounters and risks. Students are required to wear sturdy closed toe shoes, long socks, and bring a hat or visor. Students should also bring a water container, notebook, raincoat, preferred sunscreen and bug repellent (if desired). Be aware on trips there is zero tolerance policy for discrimination and abuse towards others.

Students who do not adhere to these guidelines will be dismissed from the lab and considered absent for that day and may also be reported to the Dean of Students Office for misconduct. You may also be liable for any damages to lab equipment that result from your misuse.
