Course description and learning goals

This course is designed to provide upper-level undergraduate and graduate students with experience in reading, analyzing, critiquing, and discussing scientific publications. This will be done in the context of classical and modern evolutionary developmental biology techniques. After introduction of techniques, students will lead classroom discussions of selected primary literature. Oral and visual description and examination of scientific concepts is a fundamental tool in academia as well as other careers. This course will give students experience in these processes.

Students will each be responsible for presenting 3 papers over the semester: the student will present relevant background/introduction (5-10 min) and the research presented by the publication including analysis/critique (10-15 min). All students not presenting will be expected to participate in discussion. One paper presented will be part of the introduction of the topic and will focus more on the history/significance of a technique/topic (see schedule below), and 2 papers presented will focus on modern use of the technique. Papers will be assigned at least one week in advance.

Students will also benefit from periodic seminars from faculty at UF that conduct research in the area of evo devo and related fields.

How your success will be determined

Your grade will be determined by your presentation as well as your participation in discussions.

Presentations 60% (20% from each of 3 presentations)

Participation 40%

Students will have access to the rubric used for grading the presentation. We emphasize open discussions, welcoming everyone's thoughts on the rigor, practicality, ethics, down-sides, and up-sides of the research that we analyze. As such, students will respect other's thoughts and opinions. Students not participating will be called out.

The next week will be a journal-club style discussion of 2 papers (2 groups) approx. 20 min each.
